0900: Meeting called to order by Jerry Haag (K6GAC) on Saturday, January 29, 2011 at the El Camino Hospital Rooms E, F and G. There were 91 attendees.

## Opening Remarks: Jerry Haag (K6GAC)

Jerry thanked members for their support and help during the year with activities and the flea market. It has been a quiet year for SPECS. The repeater is stable, but there were outside threats to the 2m-band plan from NARCC (Northern Amateur Relay Council of California, [www.narcc.org](http://www.narcc.org)).

## Introduction of the Speaker: Rob Goodson (N2RAG)

The speaker was Rob Goodson (N2RAG), San Mateo County American Red Cross.

### **Topic: The San Bruno Gas Explosion and Fire - The Initial Radio Response Lessons Learned in the First Forty Minutes**

Crews on ground knew it wasn't aircraft crash because there was no smell of aviation fumes. Incoming crews were told it was an aircraft crash because that was the easiest way to get them prepared.

Cell phones were unreliable and in overload. There were not enough landlines. Amateur radio was the main link between sites (Burlington Red Cross, San Bruno EOC, ICP, and Evacuation Center). Net control was in Millbrae for the first 40 minutes on WW6BAY.

Emergency Communication literature is good for the steady state response, but not for first 40 minutes. For the first 40 minutes a single operator must be able to control three radios: Bay-Net repeater, Red Cross 47 MHz radio, and San Mateo County OES. Operator works from a single location, with no headphones. Speakers are separated in space to distinguish radios. Radios are equipped with at least 4 feet of cord so they can be moved together for use by one operators and then moved apart as more operators arrive.

The first new person to arrive is the message runner. The second person to arrive is the message taker. The third person to arrive puts a situation summary on a white board.

Put carbon paper in your Go Kit to make copies of messages. Have extra pens and pencils in GO kit because everyone else takes pens. Have large paper maps (not Thomas guide) to get the large picture of the situation.

Minimize distractions by having unrelated activities and conversations outside of communication room. Army MARS, WW6BAY, S.F. NERT message handling was training that worked. The Quick Response Guide must be 10 pages or less, current, and pre-printed.

The top five lessons learned are:

- 1) Communication room must be maintained, not an obstacle course
- 2) Three radios must be within easy reach of single operators initially
- 3) Equipment must be ready to go before the incident occurs
- 4) All personnel must have training on ACTUAL Communication room equipment and procedures
- 5) First person to arrive runs three radios, second is the runner, third is the logger.

**Secretary Report: Michael Murray (KI6JDY)**

No corrections. Jerry declared the minutes approved since there were no objections.

**Treasurer Report: Wes Freeman (KG6POV)**

SPECS started 2010 with total assets of \$19,848 and ended 2010 with assets of \$23,568, which was an increase of \$3,720. The Flea Market net income was \$1,764. ROCHE Corporation donated various Ham Radio items to SPECS which were sold for \$1,919. SPECS has 140 paid members. Janie Taylor (KI6SER), and Andy Rose (KI6SEP) inspected the SPECS UG financial records for 2010. The full Treasurer report is in Appendix A.

**1st VP Report: Maynard Stevenson (W7MVT)**

Read about the Flea Market in the Newsletter. Concession stand brought in paltry a \$400. Next year SPECS hosts the June Flea Market. Scott Overstreet (N6NXI) added that SPECS now has storage and can take donations earlier than just before the flea market. Donations of ham and test equipment are desirable, but not computer stuff.

**Recognition of Annual Meeting Helpers: Doug Greig (KG6DSV), 2nd VP**

Doug thanked El Camino Hospital and its AV contact; Rod Goodson, the presenter; June Welsh (KF6WPQ) for providing the food and drink, and Phil Henderson for taking pictures.

**Training Report: Jerry for Jim Clark (N6JRC)**

Jerry reported that many training efforts were made, but there were lots of obstacles. See Newsletter for details.

**Repeater Association Report: Peter Griffith (WA6VAQ)**

Peter Griffith is the trustee of the Repeater Association. There is \$5,000 in the SPECS RA account. Their only expense has been \$20/month for the phone bill. Scott Overstreet reported that there has been no news on the repeater move. Dave Platt (AE6EO) encourages people to use the repeater and he will go over the repeater control codes at end of meeting. To get information about the 2m band replan, Dave encourages one to go to NARCC web site.

## Past President Report: Dru Anderson (KG6LAD)

Dru reported her interest, as past president, in increasing new youth and adult ham radio operators. She noted that many people get interested in ham license through CERT activities in their communities. She wears two hats – as a CERT Supervisor in the city of Los Altos Hills, and as a member/past chair of the LAH Emergency Communication Committee. She suggested one way to encourage new hams net skills would be an informal net activity on a non-Monday for to discuss net protocol, troubleshoot equipment or antenna problems, and similar FAQs.

## SPECS Treasurer's Report for 2010

January 29, 2011

Our checkbook balance on January 1, 2010 was **\$4,848.30**. We had **\$15,000.00** invested in CDs, so our total assets were **\$19,848.30**.

Our checkbook balance on December 31, 2010 was **\$8,200.84**. The total value of our two CDs was **\$15,367.42**. Adding the CDs to the Checkbook balance, our cash assets are **\$23,568.26**. Our total income for 2010 was therefore **\$3,719.96**.

Income from member dues in 2010 was **\$750.00**.

Income from bank interest in 2010 was **\$71.69**. Our CDs now pay interest monthly, unlike 'traditional' CDs which have prepayment penalties. I will therefore begin to report the interest as it accrues. The accrued interest from 2009 was **\$295.73**, which is included in the **\$15,367.42** amount above.

The Electronics Flea Market resulted in a net income to SPECS of **\$1,764.73**. (Receipts were \$5,817.41 (gate = \$3,060, donation table = \$1,648.40 and food = \$1,109.01) and expenses were \$4,052.68. Expenses include a payment of \$1,625.00 to ASVARO and \$1,764.72 transferred to the Repeater Association.

The Roche Corporation donated various Ham Radio items to SPECS. Jerry Haag handled the sale of these items, which produced a net income of **\$1,919.00**.

Meeting and newsletter expenses were **\$244.18**, the mailbox fee was **\$228.00**, and liability insurance was **\$589.00**.

There were no Repeater Association expenses in 2010, other than the transfer of Flea Market funds.

There were no outstanding bills at the end on 2010.

We had a total of 140 dues paying members in 2010. One hundred members (71%) indicated that they are ARRL members.

Janie Taylor, KI6SER, and Andy Rose, KI6SEP, examined the Treasurer's report, expense receipts, written checks, deposits and bank statements, and found that all records were in order.
